"Ordinarily the question of proximate cause is one for the jury and it is only when the facts are such that all reasonable persons must draw the same conclusion from them that the question of law arises." Bagby v. T. B. Bagby & Sons, 244 S.W.2d 556, 559 (Mo.1951); Schipper v. Brashear Truck Co., 139 S.W.2d 801, 804 (Mo.1940). The trial court could have reasonably concluded that the jury's answer to Special Issue No. 1 was not necessarily against the great weight and preponderance of the evidence, and that the jury was not clearly wrong in finding a causal relationship between the automobile's failure to yield the right-of-way and the accident. The evidence at trial was that at the time of the accident the Highway 19 overpass was an unlighted structure with no sign and no traffic control lights. The defendant operator had ample reason for continuing on the roadway after the accident and before the accident in question. The jury could have concluded from the evidence that his failure to yield the right-of-way was not the proximate cause of the accident. Point denied. The judgment of the circuit court is affirmed.
